- Acquired new Tech Soup PDF Pro 2020 license for RDSFSC (\$65 - no expiration)

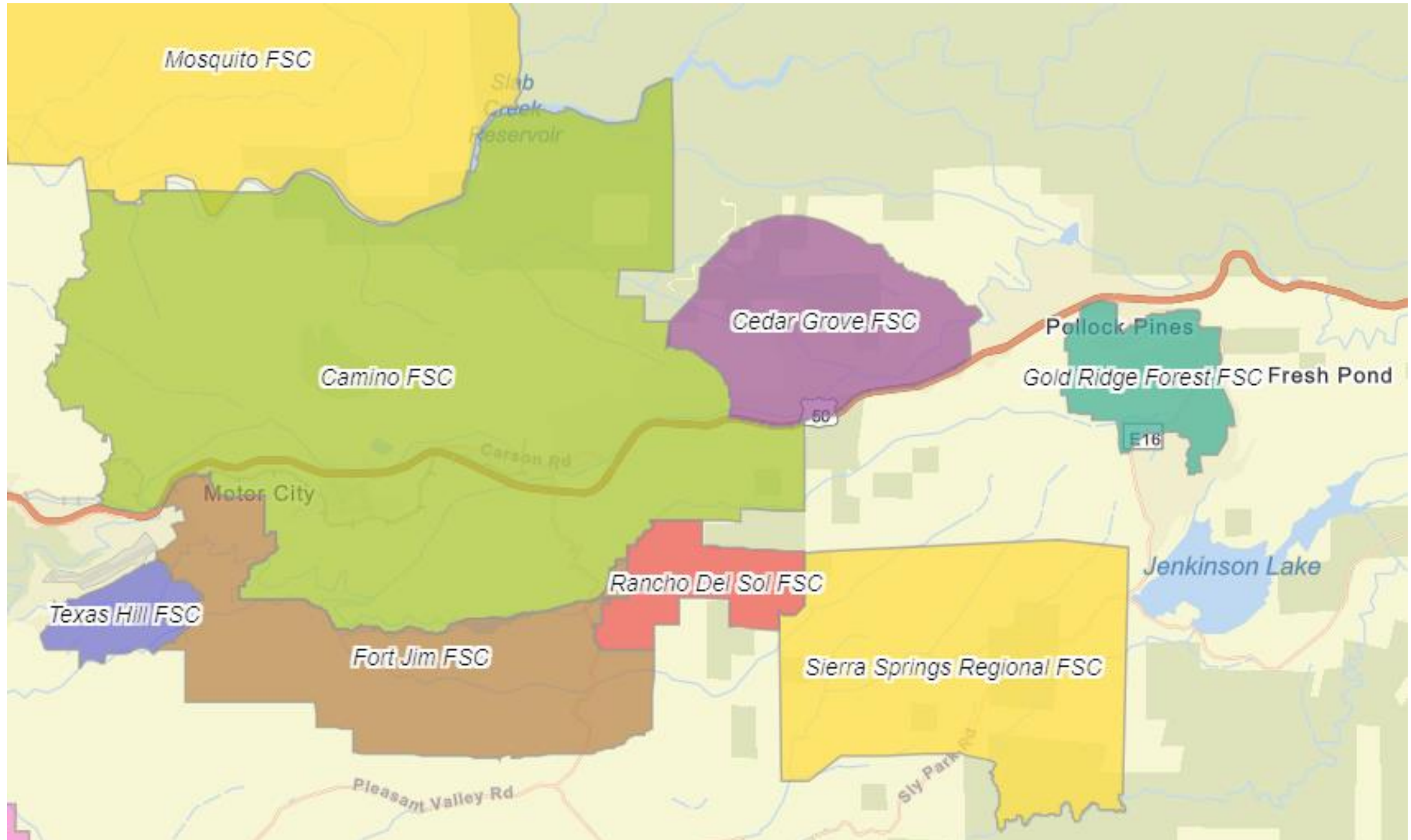
3-19-25 EDCFSC Meeting

- Janet Barentson (Treasurer) opened the meeting with a Moment of Silence honoring EDC Fire Chief Lucas Shepard who tragically died in a snorkeling incident in Hawaii on 3/14/25
- Vice-Chair Report – Dorothy (Chair Ken Pimlott was absent)
 - Launch of the new website did happen not in February as planned. New goal “ASAP”
 - EDCFSC Assistance Program Coordinator (Jessica Isabel) quit unexpectedly and that is causing delay issues – new Exec Admin Jen & Secretary Carrie filling in as much as possible
 - Dorothy now representing EDCFSC on new OWPR Public Outreach Working Group (POWG) trying to coordinate agency support of public events

3-19-25 EDCFSC Meeting (cont.)

- Treasurers Report (Janet)
 - Reviewed January Financial Report and Board approved
 - Federal funding status remains unknown (Stevens Authority & Title III funds secure). Education & Training Grant still pending – don't spend yet
 - All Assistance Programs (Def Space, Haz Tree and Chipping) and Green Waste events remain functional and funded
- Secretary's Report (Angel)

 - EDC BOS to issue Wildfire Season Proclamation in early April
- RCD (Courtney) – Placerville Wildfire Resiliency Study complete and will be posted soon

 - Only 13 assessments performed last month by 70 trained assessors
